#### Delivery Method:

- 6 weeks face-to-face, including on-site rail facility assessment activities (excluding weekends)

#### Funding Eligibility Criteria:

- 15 years or over
- No longer at school
- QLD permanent resident
- An Australian citizen, Australian permanent resident, New Zealand citizen or humanitarian visa holder
- Must not hold, or be enrolled into a Certificate III or higher level qualification
